WINTER TIRES REBATE PROGRAM TERMS AND CONDITIONS

1. QUALIFIED CUSTOMERS:

A Qualified Customer is a person who:

- a. Makes a qualified purchase between September 27th and October 10th 2013 (Qualified Sales Period) at a Canadian Tire store;

2. ELIGIBLE TIRES:

Purchase and install four (4) winter tires as designated by the "Mountain Snowflake" and provided such tires are not returned or refunded, they shall be eligible for this rebate ("Qualified Purchase").

3. TEMPERATURE AND RECORDING REQUIREMENTS:

National Average Temperature requirements (excluding Nunavut, Northwest Territories and Yukon): The National Average Temperature is an average of the maximum daily temperature (excluding humidex and windchill) as recorded by Environment Canada at the Designated Recording Stations noted below on the Recording Date.

If one of the Designated Recording Stations specified below is not available, then the available maximum daily temperature recording from the Environment Canada Recording Location nearest the unavailable Environment Canada Recording Location will be used to determine the National Average Temperature.
