## AFFIDAVIT OF ELIGIBILITY AND LIABILITY/ PUBLICITY RELEASE ESSENTIAL RIDES FOR ESSENTIAL WORKERS PROMOTION

I am submitting this Affidavit/Release with the understanding that it will be used to determine my eligibility to receive a gift in the **ESSENTIAL RIDES FOR ESSENTIAL WORKERS PROMOTION** (the "Promotion"), sponsored by Specialized Bicycle Components Canada, Inc. (the "Sponsor").

In addition, I represent that as of the date I participated in this Promotion and the date of this Affidavit/Release, I am not and was not an employee (or an immediate family member (spouse, parent, child or sibling or respective spouse, regardless of where I reside) or household member (whether or not related) of an employee) of Sponsor, a participating retailer or their respective parents, affiliates, subsidiaries, or advertising or promotion agencies.

I grant Sponsor and its designees the right to use my name, address (city and state), photograph, voice and/or other likeness and gift information for advertising, trade and promotional purposes without further compensation, in all media now known or hereafter discovered, worldwide in perpetuity, without notice or review or approval, unless prohibited by law.

I warrant and represent that I have the full right and power to enter into this Affidavit/Release, and that the terms of this document do not in any way conflict with any existing commitment on my part.

I agree that this Affidavit/Release supersedes any prior understandings between myself and the Sponsor relating to the rights granted herein and no provision of this Affidavit/Release can be modified by any other instrument, invoice or document unless in writing and signed by the parties hereto.

It is understood and agreed that this is a complete RELEASE and DISCHARGE of all claims and rights of the undersigned against the Released Parties, and that no action will be taken by or on behalf of the undersigned with respect to any such rights; it being understood that this release shall be binding upon the parents, guardians, heirs, executors, and administrators of the undersigned.

If any statement made by me in this Affidavit/Release is false or if I am otherwise deemed ineligible or unable to accept a gift for any reason, then, in addition to any other remedies that may be taken against me, I agree to return to the Sponsor the gift awarded to me, or its cash equivalent.
