

## Bealls Day PGA TOUR® Mens' Outfit Giveaway Sweepstakes ("Sweepstakes")

### 2014 OFFICIAL RULES

#### NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.
