

Lee® iPad A Day Giveaway Sweepstakes ("Sweepstakes")

2013 OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING.

1. ELIGIBILITY: Open to Legal Residents of Florida who are eighteen (18) years of age and over. The following individuals are not eligible to enter or win a prize: employees, contractors, directors, and officers of Lee and Bealls Department Stores, Inc. ("Sponsors"), its parent, subsidiary and affiliated companies, and the web design, advertising, fulfillment, legal, judging, administrative, and Sweepstakes agencies involved in the administration, development, fulfillment, and execution of this Sweepstakes (collectively, "Sweepstakes Parties"), and the immediate family members (spouse, parent, child, sibling, grandparent, and spouse or "step" of each) and those living in the same household of each such person (those persons whether related or not who live in the same residence for at least three months during the twelve-month period preceding the start date of the Sweepstakes).

2. TO ENTER: There are three (3) methods of entry: in store at Participating Bealls Department Stores, via the Sweepstakes Application on Facebook and on BeallsFlorida.com.

To enter in a Bealls department Store: Fill out the official entry form on special displays at participating Bealls Department stores, clearly hand print your name, address, zip code, email address, date of birth and telephone number. Drop your entry into the official Sweepstakes boxes located in the Bealls store.

To enter via the Sweepstakes Application on Facebook: Go online to the Bealls Florida page on Facebook.com, www.facebook.com/BeallsFlorida (the "Web Site"), during the Sweepstakes Period and click on the link to the "Lee® iPad A Day Giveaway" Sweepstakes " page to access the Sweepstakes Application. After you access the Sweepstakes Application, follow the on-screen directions to complete and submit the online entry form to receive one (1) entry into the Sweepstakes.

To enter via the Sweepstakes Website: Visit www.BeallsFlorida.com ("Website") during the Sweepstakes Period and click on the "Coupons & Events" link, then click on the "Lee® iPad A Day Giveaway" Sweepstakes " link then follow directions to complete and submit the online entry form to receive one (1) entry into the Sweepstakes.

Internet access and a valid email address are required to enter. Limit one (1) entry per person/email address or physical per day regardless of entry method. If more than one (1) entry per day is received from the same person or email address only the first entry received will be considered valid and Sponsor may choose to disqualify all entries submitted by that person at Sponsor's sole discretion. Entrants must fully complete and submit all required data on the online entry form to be eligible; incomplete entries are null and void. All materials submitted become the sole property of Sponsor and will not be returned. Entries generated by a robotic, programmed, script, macro or other automated means are prohibited and will be disqualified; any use of automated methods of entry may result in disqualification. By participating, entrants agree to abide by and be bound by these Official Rules.

3. DRAWING AND ODDS OF WINNING: One (1) Grand Prize winner will be selected in a random drawing from all eligible entries received on each day of the sweepstakes promotion. All non-winning entries for each day will be eligible for the next day's drawing. Odds of winning depend on the number of eligible entries received. Drawings will be conducted at the end of each business day, from November 10, 2013 through November 14, 2013, by a Sponsor representative, whose decisions shall be final and binding on all matters relating to the Sweepstakes.
